* **PAYING YOUR TAXES IN TIME**

Please pay your tax now instead of waiting till 31st March.

* **APPLYING FOR A HOLDING NUMBER**, if no holding number has been assigned or if your building has not yet been assessed for holding tax.

* You may apply with the following documents :

* **Prescribed form for Assessment**

* **ROR of the land**

* **CDA approved Plan**

* **VOLUNTARILY DISCLOSING ANY ADDITION / EXTENSION MADE TO YOUR EXISTING BUILDING.** You may apply in the **PRESCRIBED FORM FOR REASSESSMENT** giving details of additional construction i.e., no. of floors and / or rooms added, their area, purpose for which this extended portion is used etc.

HOW TO CALCULATE HOLDING TAX FOR YOUR BUILDING :

A) Categories of buildings and rates of annual rental value :

Residential Buildings	: Rs. 2.00 per sqft.
Small shops (Other than show rooms / and private educational institutions	: Rs. 5.00 per sqft.
Kalyan Mandap, Gold shop, Nursing home, Hotel & Lodging etc.	: Rs. 7.00 per sqft.
Bank, Insurance, Companies, & Show rooms	: Rs.10.00 per sqft.

B) Method of calculation of Holding Tax :

Annual Rental Value = Annual Rental Value per sqft. x Total built up area (in sqft.)

Annual Tax = 20.5 % of the Annual Rental Value.

Note : **Incase in a building**, different floors or in a floor different portions are being used for different purposes the rental value for different floors / portions will vary as per the above rates and total tax has to be calculated accordingly.
